**PUBLIC SAYS GOVERNOR AND LEGISLATURE DOING “TOO LITTLE”
ABOUT ENERGY TECHNOLOGY INITIATIVES AND
PROTECTING CONSUMERS FROM HIGH ENERGY COSTS**

Phoenix, Arizona, May 14, 2009. Nine of ten Maricopa County residents have opinions regarding whether the state legislature is meeting their expectations for bringing solar and other alternative energy technologies to the state and about the job it is doing to protect consumers from high energy costs. Three out of four residents have an opinion about Governor Brewer on each issue.

Six of ten residents with an opinion believe both the legislature and Governor Brewer are doing “too little” on either front. Only about three in ten disagree.

On the issue of efforts being made to attract solar and other alternative energy technologies to Arizona, criticism is particularly vigorous toward the legislature among Republicans and upper income segments of the population. Thus, 68 percent of registered Republicans and 76 percent of upper income families with an opinion are critical of the legislature. The “doing too little” rating for the governor drops to under 50 percent among Republicans but remains high among upper income segments (59%). None of the readings reveal much confidence among Republicans as to what has been accomplished to date.

Although Democrats and Independents with opinions on these issues are critical of both the executive and legislative branches' efforts to attract new energy technology to the state, it is in the area of their efforts to protect consumers from rising energy costs that the real torque is felt. Thus, 63 percent of Independents are critical of the legislature and the “doing too little” figure for that issue rises to a whopping 83 percent when assessing the governor's actions.

EDITOR'S NOTE: This Rocky Mountain Poll - Arizona (2009-II-04), is based on 500 interviews with adult heads of household across Maricopa County, conducted between April 13 and 21, 2009. Where necessary, figures for age, sex, race and political party were weighted to bring them into line with their actual proportion in the population. In a sample of this size, one can say with a 95 percent certainty that the results have a statistical precision of plus or minus 3.5 percent of what they would have been had the entire voter population been surveyed. The Rocky Mountain Poll is conducted by the Behavior Research Center of Arizona and is an independent and non-partisan research program sponsored by the Center.
